The suite of mobile apps for residents will be available to download on all mobile platforms. In order for residents to experience the suite of Bright City apps, their municipality must sign up to use the Agency App provided by Bright City (MSTI).

"Unlike social media, the goal of Bright City is to provide dedicated tools that offer unparalleled and efficient communication to and from residents with their municipal officials through the use of white labeled mobile apps.
